Eva Cosyleon said that we had a great turn out, there were quite a few different departments that attended. There were a few good presentations from our peers and a walk audit. Everyone had very good feedback/input.

8. Federal Transit Administration (FTA) & Federal Highway Administration (FHWA) updates – Aaron Bustow or Emma Belmont

9. Colorado Department of Transportation Region 2 (CDOT R2) and Headquarter Updates – Geoff Guthrie and Kathleen Collins

Geoff Guthrie talked about the 2025 Construction highlights that includes the I-25 and Hwy 50B Interchange. He also talked about the look ahead, I-25 & Hwy 50B Interchange in both directions will have a new shift in lanes. Completion schedule for early summer next year. The TC (Transportation Commission) did approve the Construction Management General Contractor for the US 50 SHIFT Project. This is the passing lanes from Pueblo County to the Kansas border. Division of Transit and Rail is getting the Pueblo Transit Vehicle Replacement Funds programmed. The new Division of Transit and Rail post-award Grant Coordinator is Leslie Ralston. Geoff also mentioned that the Highway Safety Improvement Plan (HSIP) applications are due February 20th.

The survey will be available for another 2 weeks. There is a stakeholder specific meeting on February 25th.

Kathleen Collins said that the new STAC meeting will be held on February 5th and will be in person at HQ Denver. There is a 10-Year Plan workshop on CDOT regions 1,2, and 4 projects. There is also a greenhouse gas (GHG) report that CDOT will be responsible for and the MPO's are responsible for their own.

10. Transportation Technical Committee (TTC) Updates

- a. Aviation – Pueblo Airport – Greg Pedroza said that City Council agreed to set aside \$6m to add ADA considerations and a new front facelift.
- b. City of Pueblo
 - o Public Works – Andrew Hayes
 - o Transportation Dept. – Helen Dupree said that the Lake and Orman will go out for bid in the next month or so. Mel Harmon Bridge is still under construction. Dillon and Eagleridge Roundabout still going through the acquisitions process with CDOT. Haaff/Monument project is going to go to Ad in February. City has hired a Deputy Director – her name is Molly Evans.
 - o Pueblo Transit – Ben Valdez said that the Art on the bus stops has been approved. There will be a TIP for the 2025 Operational Grant followed by a 5307 Grant. This is to buy two paratransit vehicles and a coin sorter machine. Macario Torrez said that they got a large group (31 person and 28 online) for their West Side Improvements Meeting. They are still working on the MyRide App.

- d. Pueblo County
 - o Public Works – Greg George said that Medal of Honor had a lot of issues on the project, final walkthrough with CDOT this week. The median still has a lot of work. RAISE grant meeting will be tomorrow, this will finalize the funds and get an IGA with CDOT. The

road reclaimer equipment saved them a lot of money when they did two bridge replacements. They also bought a paving machine.

- Parks and Recreation – Greg George said that they received a \$180,000 GOCO Grant, this is a planning grant to be used to Plan for the Parks and Rec Department for years going forward.
- e. Pueblo West – Shawn Winters said that the Joe Martinez Trail is close to closeout with execution modification number 2. Civic Center Trail Phase 1 will have a pre-construction meeting tomorrow. Purcell Trail Phase 1 and 2 are in construction, about 16% complete.

- Innovate to promote access and support independent living
 - **2015:** Launched homecare program
 - **2018:** Launched public fixed routes in eastern El Paso County
 - **2019:** Led and implemented Mobility on Demand Collaborative
 - **2023:** Launched On-Demand Pilot Program to provide same-day transportation to older adults and individuals with disabilities
 - **2024:** Implemented new transportation software, Ecolane, including facility portal and client mobile app

- For example, we can transport a Pueblo resident to covered medical appointments in Colorado Springs, or Denver



How It Works

Clients call envida's transportation line to put in a ride request. The Reservationist will ask for the following:

- First and last name
- Age
- Address
- Email
- Emergency contact info
- Purpose of trip
- Pick-up location
- Drop-off location

Advance Construction, Toll Credits and the State Infrastructure Bank



Colorado State Infrastructure Bank

Background

The NHS Designation Act, U.S.C § 350 (1995) provided states the opportunity to create Statewide Infrastructure Banks (SIBs). The Colorado SIB is a low interest, revolving infrastructure investment fund. This fund provides for both public and private investment opportunities for a wide array of ***highway construction, airport and transit capital projects.***

According to Colorado Revised Statute 43-1-113.5, SIB funds can be used to “...provide assistance to public and private entities for the acquisition, improvement, or construction of highways, multimodal transportation, and intermodal transportation facilities in the state...”, as long as the project is for public use.



Colorado State Infrastructure Bank

Financial Resources

Legislation authorized four SIB accounts: Highway, Aviation, Rail and Transit. Only the first two have been funded. Current accounts are 100% state funded.

Current loans outstanding:

\$40 million

Most of these are for airport improvements around the state

Available to Loan:

Highway Account - \$3.9million

Aviation Account - \$0

More funds will become available as payments come in.





Colorado State Infrastructure Bank

Loan Process

The current fund balance in the Colorado SIB is 100% state funds and all loans will be approved by the CDOT Executive Director and either the Transportation Commission (for highway or transit-related loans) or the Colorado Aeronautical Board (for Aviation Loans). There are no accounts set up for the enterprises, but the Highway account could be used for qualified projects.

Follow links on the CDOT SIB web page to submit an application. The SIB Manager will provide an initial review and draft a loan agreement for consideration and work directly with the entity authorized to enter into a loan agreement to finalize the loan. The entire process from application to approval takes approximately 60 days.

Advance Construction Definition

Advance Construction (AC) is a Federal Highway Administration (FHWA) fund management tool that allows a state to begin a transportation project using non-federal funds, even without available federal obligation authority for that project.

The state then maintains eligibility for future federal reimbursement, allowing for project acceleration and better funds management.

CDOT can later request the FHWA to convert the project to a regular Federal-aid project when sufficient funds and obligation authority become available, enabling the state to receive reimbursement for a full or partial amount of the costs incurred.

Advance Construction IS NOT Advance Payment. CDOT does not currently support “advance payment”, we only support the “reimbursement” model. We would need to hold a separate conversation with CDOT Accounting staff and FHWA if this is needed.



FHWA Authorization

Critically important: the state and local agencies must still receive FHWA authorization of the project prior to notice to proceed as with any normal project.

- Must be in the TIP and STIP.
- Must have an IGA between CDOT and Local
- Be eligible for the FHWA funds expected to obligate in future
- Comply with period of performance and other 2 CFR 200 project cost accounting and reimbursement rules



Benefits

- **Accelerated Project Delivery:** start construction sooner, preventing delays and accelerating the completion of needed infrastructure projects.
- **Fund Management Flexibility:** AC helps manage the annual limitations on federal highway funding (obligation authority), allowing states to use funds more efficiently and avoid setting aside full obligational authority for every project upfront.
- **Reduced Inflationary Costs:** Faster project completion helps to avoid cost increases due to inflation.
- **Support for Large Projects:** It facilitates the construction of large, complex projects by allowing them to begin without waiting for full funding.



Risks

- If planned federal funds do not become available, the state or local must cover the remaining costs with non-federal funds (or other eligible federal funds)
 - a. what if the TAP or Carbon Reduction Programs were cancelled
 - b. if the feds are on “continuing resolution” or we run out of annual funds
- If so many projects are AC’d the “conversion” and “reimbursements” may have to be staggered across multiple fiscal years
- Inactivity - all projects must stay active, even if “advanced”
- Work load - are there sufficient local or CDOT employees to manage additional projects in the pipeline



Toll Credits

FHWA toll credits are a financial tool allowing states to substitute additional federal funds for the non-federal share, effectively reducing state or local costs and freeing up state or local funds for other projects.

IE increase from 80% to 100% reimbursement

But those costs still have to be covered from somewhere.

Toll credits ARE NOT CASH!





Toll Credits

Toll credits can be extended to local agencies at CDOT's discretion. The local agency should state their case to CDOT for the toll credits explaining why local revenues are not available.

In response to the approval of toll credits a local would need to either cut scope of the project or secure additional FHWA funding from the MPO's award process.

ie add federal funds through the TIP.

For example: a \$100,000 project at \$80,000 fed / \$20,000 local can become either:

- \$100,000 all fed aid project by increasing the federal allocation in the TIP
- \$80,000 all fed aid project by cutting the scope down to size



Toll Credits

The local agency should state their case to CDOT for the toll credits explaining why local revenues are not available.

“Overmatch” is the opposite of toll credits.

Very often a local agency has additional local funds above and beyond the 20% share required by FHWA in a project.

Before requesting toll credits on a project the local should explore whether they are over committing match to separate project and “even out” the match across the multiple projects.



Tapered Match

Tapered Match

An FHWA tapered match is a form of Federal-aid matching flexibility that allows a project's Federal share to be higher in the early stages and decrease over time, while still meeting the overall, non-Federal matching requirement by the project's completion. This "delayed local match" provides flexibility for locals to advance projects that lack upfront funds by allowing the non-Federal share to accumulate over the project's life.

Tapered match projects must receive prior approval from FHWA.
