NOW, THEREFORE, BE IT RESOLVED BY THE PUEBLO AREA COUNCIL OF GOVERNMENTS that:

SECTION 1:

The Pueblo Area Council of Governments expresses its desire to remove the Grand Ave. & 13th St. Roundabout Project and the Lake Ave. & Jones St. Roundabout Project from the Transportation Improvement Program.

SECTION 2:

The Pueblo Area Council of Governments Expresses its desire to use its Highway Safety Improvement Program Award of \$2,370,000 for the installation of new intersection improvements at the 13th St. and Grand Ave. Intersection, Prairie Ave. & St. Clair Ave. Intersection, and Lake Ave. & Jones Ave. Intersection.

SECTION 3:

The PACOG certifies that the transportation planning process is being carried out in conformance with all applicable federal requirements; and hereby directs the Urban Transportation Planning Division to implement the necessary revisions to the Fiscal Year 2025–2028 Pueblo Metropolitan Planning Organization (MPO) TIP to include this amendment.

SECTION 4:

This Resolution shall become effective upon passage and approval.
