



2020 - 2024 Serious Injury and Fatality Crash Data for PACOG




2020-2024 Non-Motorized Serious Injuries and Fatalities Crashes





Top crash type, 2020-2024

Pueblo West - Joe Martinez Trail

Location:

Runs along the whole of Joe Martinez Blvd. The trail will extend to meet 24th street alongside Medal of Honor Blvd.

Identified Need:

No pre-existing pedestrian or bicycle trail connections to give neighborhoods near and along Joe Martinez access to nearby amenities, such as Civic Center Park, or the library.

Project Benefits:

Creates future connection for Pueblo West and Pueblo to connect bicycle networks

Gives local neighborhoods a major East-West trail that connects with planned and existing trails in Pueblo West





Pueblo County- Industrial & Purcell

Location:

Industrial & Purcell Intersection in Pueblo West

Identified Need:

Previously identified as a high-risk intersection along the local High-Injury Network



Project Benefits:

Installation of interim intersection improvements while permanent improvements are under-design

- Installation of protected left-turns for whole intersection
- Signal retiming to provide greater protection during movements



Pueblo County – Aspen Road and US 50C

Location:

Pedestrian improvements installed outside of new Circle K along US Business 50/US 50 C.



Identified Need:

Inadequate pedestrian infrastructure hurt ability to easily walk from adjacent neighborhood to nearby shopping areas



Project Benefits:

Improved Pedestrian connectivity and safer, more visible crossing opportunities to mitigate Vulnerable Road User crash risks.



City of Pueblo – Belmont Improvements

Location:

Installation of Improved ADA curb ramps along Bonforte.

Identified Need:

A 2023 Walk Audit with the local ADA commission identified that Bonforte was difficult to navigate, with sidewalks often terminating into a curb drop-off instead of a slope.

Project Benefits:

Smoother walking and rolling experience for pedestrians along the corridor





City of Pueblo – 4-Way Stops

Location:

Intersection of Hollywood & Farabaugh
Intersection of 15th & Court

Project Benefits:

Improved traffic control around Parkview and schools







Comprehensive Safety Action Plan

Description:

Joint project by the City and County to examine corridors and intersections across the region and recommend costvariable improvements to lower risk of fatality or serious injuries from crashes

- Developed a list of pre-made safetycentered projects across the whole region
- Analyzed driving behaviors at intersections by pedestrians, cyclists, and drivers
- Gave in-depth policy recommendations to improve the region's ability to improve our roadway's safety







MPO – Roundabout Safety Campaign

Description:

As roundabouts become more common, the MPO identified a drastic need to educate the public on how to safely maneuver through them.

The education campaign created a set of comprehensive tools, videos, and visual aids to help members of the public learn about current and future roundabouts, why roundabouts are important, and to help local departments educate neighborhoods as new roundabouts are installed.


Creates a defined right turn deceleration lane for westbound travel with raised median to separate traffic, improves sight distance by moving stop position for southbound traffic on Baxter Rd, and better define the southbound left turn to eastbound with a acceleration lane and buffer zone. Project also included improving advance signage and added street lighting to improve visibility through the intersection for nighttime driving.

Urgent Need

 Approach turn and Broadside accident Pattern. Did not meet warrant for signal.

- Safety, increase site distance for turning movements. Reduce speeds through traffic calming median installation.
- Operations, increased sight distance and delineated southbound left turn acceleration lane.




