

RESOLUTION NO. 25-006

A RESOLUTION APPOINTING MEMBERS OF THE TRANSPORTATION TECHNICAL COMMITTEE (TTC) AND THE CITIZENS ADVISORY COMMITTEE (CAC) TO THE PUEBLO AREA COUNCIL OF GOVERNMENTS (PACOG) TRANSPORTATION ADVISORY COMMISSION (TAC) FOR THE PUEBLO AREA METROPOLITAN PLANNING ORGANIZATION (MPO)

WHEREAS, Pueblo Area Council of Governments adopted revised bylaws to adopt changes to the Transportation Advisory Commission membership, bylaws, and meeting times by resolution 24-033 on October 24, 2024; and

WHEREAS, the Citizens Advisory Committee (CAC) consists of six members, representing one from Pueblo City Planning and Zoning Commission, one selected from Pueblo County Planning Commission, one from Pueblo Americans with Disabilities Act Advisory Committee, one selected from Pueblo Active Community Environments, one from Pueblo Plex, and one citizen at large. These members shall be appointed by the PACOG Board to serve as Citizen Advisory Committee representatives to the PACOG Transportation Advisory Commission; and

WHEREAS, Cheryl Spinuzzi, was chosen by Pueblo City Planning and Zoning Commission to be their representative for the Citizens Advisory Committee to the Pueblo Area Transportation Advisory Commission, for a term set to begin February 1, 2025 and set to expire December 31, 2027; and

WHEREAS, Richard Arko and John Wark, designated alternate, were chosen by Pueblo County Planning Commission to be their representatives for the Citizens Advisory Committee to the Pueblo Area Transportation Advisory Commission, for a term set to begin February 1, 2025 and set to expire December 31, 2027; and

WHEREAS, Laura Leyba and Tura Cowan, designated alternate, were chosen by Pueblo Americans with Disabilities Act Advisory Committee to be their representatives for the Citizens Advisory Committee to the Pueblo Area Transportation Advisory Commission, for a term set to begin February 1, 2025 and set to expire December 31, 2027; and

WHEREAS, Chuck Aksamit and Matt Pujol, designated alternate, were chosen by Pueblo Active Community Environments to be their representatives for the Citizens Advisory Committee to the Pueblo Area Transportation Advisory Commission, for a term set to begin February 1, 2025 and set to expire December 31, 2027; and

WHEREAS, John Chrisman and John Buttram, designated alternate, were chosen by Pueblo Plex to be their representatives for the Citizens Advisory Committee to the Pueblo Area Transportation Advisory Commission, for a term set to begin February 1, 2025 and set to expire December 31, 2027; and

WHEREAS, Don Bruestle has submitted an application as the citizen at large requesting to be appointed to the Citizen Advisory Committee, for a term set to begin February 1, 2025 and set to expire December 31, 2027; and

WHEREAS, the Transportation Technical Committee (TTC) consists of representatives from the City of Pueblo, Pueblo County, Pueblo West Metropolitan District, and Colorado City. These voting members shall be appointed by the PACOG board to serve as the Transportation Technical Committee representatives to the PACOG Transportation Advisory Commission; and

WHEREAS, Director of Public Works, Andrew Hayes and Civil Engineer Transportation, Sean Maik have been selected to be the voting representatives for the City of Pueblo; and

WHEREAS, Director of Pueblo Transit, Ben Valdez has been selected to be the voting representative for the Pueblo Transit; and

WHEREAS, Director of Aviation, Greg Pedroza has been selected to be the voting representative for the Pueblo Airport; and

WHEREAS, Interim Director of Public Works, Greg George and Deputy Director of Parks and Recreation, Amanda Hobson have been selected to be the voting representatives for the Pueblo County; and

WHEREAS, Director of Operational Support, Shawn Winters has been selected to be the voting representative for the Pueblo West Metropolitan District; and

WHEREAS, District Manager, James Eccher has been selected to be the voting representative for Colorado City/Rye.

NOW, THEREFORE, BE IT RESOLVED BY THE PUEBLO AREA COUNCIL OF GOVERNMENTS that:

SECTION 1:

The following individuals are hereby appointed, and their designated alternates approved, as the Citizen Advisory Committee representatives to the PACOG Transportation Advisory Commission appointed for a term expiring December 31, 2027.
