

RESOLUTION NO. 26-011

A RESOLUTION AMENDING THE PUEBLO AREA COUNCIL OF GOVERNMENTS FY (FISCAL YEAR) 2025-2028 TRANSPORTATION IMPROVEMENT PROGRAM (TIP) ASSIGNING FY 2026 FEDERAL TRANSIT ADMINISTRATION 5310 FUNDS IN THE AMOUNT OF \$25,016, FY 2026 COLORADO DEPARTMENT OF TRANSIT CLEAN TRANSIT ENTERPRISE FUNDS IN THE AMOUNT OF \$388,947, AND A PRIVATE MATCH OF \$25,016 FOR A TOTAL OF \$438,979 TO EXPAND ENVIDA'S TRANSIT OPERATIONS INTO THE PUEBLO AREA AND PURCHASE NEW VEHICLES

WHEREAS, the Pueblo Area Council of Governments (PACOG) and the Colorado Department of Transportation have cooperatively developed the Fiscal Year (FY) 2025-2028 Pueblo Area Transportation Improvement Program (TIP) in conjunction with the State Transportation Improvement Program (STIP); and

WHEREAS, all projects that appear in the FY 2025-2028 PACOG Transportation Improvement Program shall also be included in the Colorado State Transportation Improvement Program, if required; and

WHEREAS, the PACOG/Metropolitan Planning Organization (MPO) planning staff has received a request from the Colorado Department of Transportation for the following projects to be added to the FY 2025- 2028 Transportation Improvement Program.

This Resolution shall become effective upon passage and approval.


