

RESOLUTION NO. 2021-001

**A RESOLUTION DESIGNATING A PLACE FOR THE POSTING OF
NOTICE OF PUBLIC MEETINGS OF THE PUEBLO AREA COUNCIL
OF GOVERNMENTS FOR CALENDAR YEAR 2021**

WHEREAS, pursuant to Section 24-6-402(2)(b), C.R.S., all meetings of a quorum or of the Council of the Pueblo Area Council of Governments, at which any public business is discussed or at which any formal action may be taken, are declared to be public meetings open to the public at all times; and

WHEREAS, Section 24-6-402(2)(c), C.R.S., mandates that any meeting of the Council at which the adoption of any proposed policy, position, resolution, rule, regulation, or formal action occurs or at which a majority or quorum of the members of the Council of the Pueblo Area Council of Governments is in attendance, or is expected to be in attendance, shall be held only after full and timely notice to the public, which notice may be provided by posting no less than twenty-four hours prior to holding of the meeting in a public place designated annually by the Council at its first regular meeting of the calendar year. The posting shall include specific agenda information where possible; and

WHEREAS, in addition pursuant to C.R.S. 24-6-402(2)(c)(III), the Council may give full and timely notice of a public meeting if the Council posts the notice, with specific agenda information if available, no less than twenty-four hours prior to the holding of the meeting on a public website of the Council; and

WHEREAS, the Council desires to adopt a procedure whereunder notice to the public of such meeting(s) shall be given by posting of notice of the meeting(s) online on the Pueblo Area Council of Governments' website and if unable to post a notice online in exigent or emergency circumstances due to interruption in internet services that prevents the public from accessing the notice online, this Council will give notice to the public by posting in the rotunda area of the Pueblo County Courthouse, 215 West 10th Street, Pueblo, CO 81003 and the lobby of Pueblo City Hall, 1 City Hall Place, Pueblo, CO 81003, no less than twenty-four (24) hours prior to the holding of the meeting designated in the notice and, where possible, the posted notice shall include specific agenda information.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Pueblo Area Council of Governments that effective January 1, 2021:

SECTION 1.

- (A) Public notice of all public meetings held during Calendar Year 2021 by the Council of the Pueblo Area Council of Governments shall be given by the posting of notice of any such public meeting in the rotunda area of the Pueblo County Courthouse, 215 West 10th Street, Pueblo, CO 81003 and the lobby of Pueblo City Hall, 1 City Hall Place, Pueblo, CO 81003 at least twenty-four (24) hours prior to the holding of the meeting described in the notice.
- (B) The public place for the posting of such notices during year 2021 shall be the Pueblo Area Council of Government's meeting webpage at <https://county.pueblo.org/pacog/administration> and in the rotunda area of the Pueblo County Courthouse or lobby of Pueblo City Hall, if unable to post a notice online in exigent or emergency circumstances due to interruption in internet services that prevents the public from accessing the notice online.


SECTION 2.

Where possible, the posted notice shall include specific agenda information applicable to the meeting.

SECTION 3.

This Resolution shall become effective upon adoption.
