

RESOLUTION NO. 2022-013

A RESOLUTION AMENDING THE PUEBLO AREA COUNCIL OF GOVERNMENTS' (PACOG) FY 2022-2025 TRANSPORTATION IMPROVEMENT PROGRAM (TIP) TO RE-CATEGORIZATION OF AWARDED MMOF FUNDING FOR SIDEWALK IMPROVEMENTS ALONG PRAIRIE AVE. FROM NORTHERN AVE. TO PUEBLO BLVD. AND DIRECTING THE URBAN TRANSPORTATION PLANNING DIVISION TO EXECUTE SAID AMENDMENTS

WHEREAS, the Pueblo Area Council of Governments and the Colorado Department of Transportation have cooperatively developed the Fiscal Year 2022-2025 Pueblo Area Transportation Improvement Program (TIP) in conjunction with the State Transportation Improvement Program (STIP); and

WHEREAS, all projects that appear in the FY 2022-2025 PACOG Transportation Improvement Program shall also be included in the Colorado State Transportation Improvement Program, if required; and

WHEREAS, the PACOG planning staff have received a request from the City of Pueblo for the following project to be Re-Categorized into the FY 2022-2025 Transportation Improvement Program:

THEREFORE, BE IT RESOLVED, BY THE PUEBLO AREA COUNCIL OF GOVERNMENTS that:

SECTION 1:

The FY 2022-2025 PACOG TIP is hereby amended to by Sub-Categorization of the phases for the following project utilizing Multi-Modal Option Funds (MMOF) for the construction of sidewalks and various improvements to handicapped ramps, to improve the safety and mobility of citizens.

SECTION 2:

This Resolution shall become effective immediately upon passage and hereby authorizes and directs the Urban Transportation Planning Division to administer and execute these amendments to the Pueblo Area MPO Transportation Improvement Program in accordance with all applicable State and Federal laws and policies.
